NO.SO(ME-I)7-16/2022(CIP)(JAN): Pursuant to the decisions made in the Post-Graduate Admission Committee (PGAC) meeting held on 12.12.2022, the Competent Authority has been pleased to notify that the marks of distinctions shall not be counted under the experience marks as stated under clause 13(8)(iv) of the Policy and Procedure Manual (PPM) of Post-Graduate Residency of Level-III Programs notified vide No.SO(ME)7-6/2020(CIP) dated 11.03.2021, for January 2023 Induction and afterwards. An independent category for award of marks has been created on the basis of positions secured by the applicants in professional examinations (MBBS / BDS) at the University Level (and not at the level of College / Institution). The criteria for award of 05 marks for position at the University level shall be as follows:

Sr. No.	Award of Marks
1.	01 mark each for MBBS Graduates who secured either 1st or 2nd or 3rd position in professional examination at the University level (and not at the College / Institution level)
2.	1,25 marks each for BDS Graduates who secured either 1st or 2nd or 3nd position in each professional examination at the University level (and not at the College / Institution level)
