1.	Graduates from public sector / private sector institutions in Punjab, who complete House Job in recognized Teaching Hospitals that are attached with Medical College / Dental College / University in Punjab from where the candidates had graduated	05
2.	Graduates from public sector/ private sector institutions in Punjab, who complete House Job in such public sector/ private sector recognized Teaching Hospitals in Pakistan that are not attached with Medical College/ Dental College/ University from where the candidates had graduated	2.5
3.	Graduates from public sector/ private sector institutions in Pakistan but outside Punjab, who complete House Job in such public sector/ private sector recognized Teaching Hospitals in Pakistan that are attached or not attached with Medical College/ Dental College/ University from where the candidates had graduated	2.5
4.	Foreign Graduates who complete House Job in any public or private sector recognized Teaching Hospital in Punjab	2.5
